Our flexible degrees offer student interns for varying lengths and timeframes.

Durations Available

- 10 - 30 days (legal placements only)
- 120 hours (paid or unpaid)
- 240 hours (paid or unpaid)
- 480 hours (paid)
- 3 months (paid)
- 6 months (paid)
- 12 months (paid)

Internships generally take place during our University teaching periods but we can also explore other options to suit your business.

Teaching periods

- Semester 1 (March - June)
- Semester 2 (July - October)
- Summer (November - March)

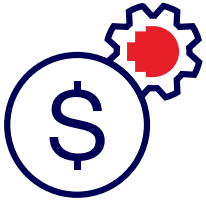
PhD and Masters by Research internships can take place anytime during the year.

Focus on Flexibility

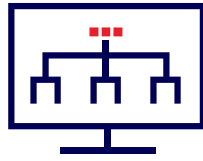

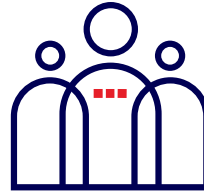

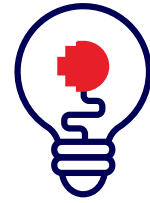
